#### **STEP 2 HOMEPAGE**

We will send you designs to choose from, customised with your brand and logo.

#### **STEP 3 INNER PAGE DESIGN**

Your inner pages will be created for your approval.

#### **STEP 4 COPY & BUILD**

Our copywriters will create the content and the website will be customised to your brand with colours, logo, images and content.

#### **STEP 5 BROKER REVIEW**

We will send you the website to review and it's your chance to provide us with feedback. You can give us one round of amends to complete during this period.

#### **STEP 6 COMPLIANCE**

Broker Network's Compliance Team will review your new site so that it remains compliant with FCA regulations and any relevant alterations will be made.

#### **STEP 7 LAUNCH**

#### **TERMS AND CONDITIONS**

1. **PROJECT TIMESCALES** - Once you have returned a signed copy of the Project Sign Off Document to your Marketing Executive, work on your Fast Track Website will be booked into the production schedule, with an aim to complete it within eight weeks of the start date.

This lead time is based on timely feedback with one round of amends from yourself. It does not take into account any delays from external providers, or additional amends.

- 2. AMENDS PROCESS You are entitled to one round of amends for images, colours and content. Further changes to style elements and content may be made, however changes which exceed the initial amends before going live will be scheduled outside the projected timeframe and may result in a delay in the site going live. Once your website has been put live any further changes or amends requested by the broker will need to be rescheduled into the next available time slot.
- **3. DESIGN LIMITATIONS** As a Fast Track Website, you are limited by the existing structure of your chosen design and changes can only be made to images, colour and content.
- **4. DOMAIN NAMES** A domain name of your choice can be purchased subject to availability, or alternatively an existing name can be transferred as part of our hosting package. This should be your company name or trading style registered with the FCA. Broker Network accepts no responsibility for a delay in transfer of a domain name held by another provider.
- **5. HOSTING** Hosting for websites is charged from £95 plus VAT per year and is obligatory for fast track websites. If you have an existing domain name which is hosted elsewhere and you wish to continue with your current provider, then please contact your marketing excecutive to discuss your options.
- **7. CONTENT MANAGEMENT SYSTEM (CMS)** Your website will be provided with a CMS, which you can use to add and edit pages on your website. You will be provided with training on how to use the system.
- **8. SITE OWNERSHIP -** Once live, the website and its content becomes the property of your company. Should you resign from the network your website will remain your property.
